To: Jeffrey A. Howe, a Constable of the Town of Dixfield, in the County of Oxford, State of Maine:

GREETING:

In the name of the State of Maine, you are hereby required to notify and warn the inhabitants of the Town of Dixfield in said county and state, qualified by law to vote in town affairs, to meet at the Dixfield Swasey-Torrey American Legion Post 100 at 8 River Lane in said Town on Tuesday, the 8th day of November, 2016 A.D., at eight o'clock in the forenoon, then and there to act upon Article 1 and by secret ballot on Articles 2, 3 and 4 as set out below, the polling hours therefor to be from eight o'clock in the forenoon until eight o'clock in the afternoon, said articles being the following:

Article 1: To elect a moderator by written ballot to preside at said meeting.

Article 2 (Question 1): Do you favor the withdrawal of the Town of Dixfield from Regional School Unit #10 subject to the terms and conditions of the withdrawal agreement dated April 25, 2016?

Article 3 (Question 2): In the event Question #1 is approved, do you favor approving the school administrative reorganization plan prepared by the Reorganization Planning Committee to reorganize the Towns of Canton, Carthage, Dixfield and Peru into a regional school unit, with an effective date of July 1, 2017?

Note: An attested true copy of the full text of this ordinance has been posted together with this warrant, and copies are available from the office of the town clerk and will be available at the polls.

Article 4 (Question 3): Shall an Ordinance entitled WIND ENERGY ORDINANCE FOR THE TOWN OF DIXFIELD dated June 12, 2012 be repealed allowing the State of Maine's Department of Environmental Agency to regulate Wind Energy Facilities constructed in the municipality?
