## NOTICE OF SALE OF TAX- ACQUIRED PROPERTY

The Selectmen of the Town of Dixfield are soliciting bids for the sale of the municipality's interest in six (6) tax-acquired properties listed below. Each bid must be in writing and in a sealed envelope marked "Tax Acquired Property Bid" on the outside. Each bid may be for one property only; any person wishing to bid on multiple properties must submit a separate bid for each one. Each bid must also include the bidder's name, mailing address, phone number, property bid upon, and amount of bid. **All bids must be received at the Dixfield Municipal Building, Attention, Dustin M. Starbuck, Town Manager, PO Box 808, 46 Main Street, Dixfield, Maine 04224 by December 7, 2018 at 4:00 p.m.** Late bids will not be opened or considered.

Bids will be opened and reviewed by the Selectmen at the Ludden Memorial Library on December 10, 2018 at 5:30 p.m. The Board of Selectmen reserves the right to reject any and all bids. Each successful bidder shall have 15 days from the date of the bid acceptance in which to complete the purchase. Each property will be conveyed by a quitclaim deed without covenants. In the event that a successful bidder fails, for any reason, to complete the purchase in the time stated, the bid acceptance is void. The Board of Selectmen may thereafter negotiate a sale of the property with any or all unsuccessful bidders.

The successful bidder shall be responsible for any and/or all occupants and any contents of the purchased tax-acquired property in accordance with State Statutes. The property for sale is described on the Town's tax maps:
