**First Half of Year**

**November 1, 2019 or 45 days after taxes are committed, which every date is later.**

**Second Half of Year**

**April 16, 2020**

Explanation: On June 1, 2019, the Town voted at its annual Town Meeting that taxes for the first half of the year due and payable on September 15, 2019. RSU 56's budget will not be approved until after September 15, 2019. In order to prevent setting the tax rate too high or too low, taxes should not be committed until after RSU 56's budget is finalized. Once RSU 56's budget is finalized, the appropriate tax rate can be set, taxes committed, and the tax bills mailed. In the interim, taxpayers may make estimated payments towards their 2020 taxes before the due date and those monies will be applied to their accounts.
